Neuter/Spay Contract

Peekapoo Zone Puppies raise only first-generation Peekapoo Puppies. We require the new owner of the puppy to neuter/spay on or before six months of age or at the time indicated by a veterinarian.

Possible date to neuter/spay your puppy:

In some cases, families can not take care of their puppy and give it away to a family member. Being with the family member who might not take care of the puppy as they should, leading to the neglect of the puppy and causing unwanted births. Then the puppies that came from the unwanted births are again given away carelessly. Down the road, the puppies end up dead, sick, or in shelters. This can go as far as people just having fun breeding our puppies without knowing the real responsibility of what they're doing and causing dogs and puppies great pain and sorrow.

This is why we try to encourage people to neuter/spay their puppies when they are in your possession. We know that words are not enough and now require you to neuter/spray the puppy. Consequently, when you nurture/spay you are putting an end to this sad cycle

For The Owner

It will be your responsibility to inform and prove to Peekapoo Zone Puppies that you have neutered/spayed your puppy. If you do not provide this in due time Peekapoo Zone Puppies will contact you and ask what has happened with the information required.

When you have given the receipt form proving that you have already neutered/spayed your puppy Peekapoo Zone Puppies will be compromised to give you the original Continental Kennel Club Registration form.

In regards to the registration form, the owner will be able to yield authenticity. What would happen if your dog was lost or stolen? You would have the proof to get them back. When you register your dog with CKC, you receive an official certificate proving that you are the owner of the dog. Not to mention, having a puppy birth certificate is official documentation..

What happens if the contract isn't fulfilled?

Peekapoo Zone Puppies requires you to acknowledge and understand the consequences. If you do not abide by the contract and unable to execute sign, then this is the moment to halt the process.

All of the families that purchase a puppy at Peekapoo Zone Puppies will hereby sign and complete the neuter/spay contract.

If you fail with the requirements of this contract Peekapoo Zone Puppies will have the right to bring your puppy back to our installations without any kind of refund.

We will also file a civil lawsuit at the court of Nacogdoches county. The owner and co-owner of the puppy will be responsible for all the costs of the lawsuit. In addition, they will also be responsible for paying the amount of money that Peekapoo Zone Puppies will set in such a claim, which is determined at a later time.
